Below are the principal 2026 tax due dates. The effect of Saturdays, Sundays, and holidays has been considered.

Date	Entity/Individual	Forms/Estimated Payments	Action
15-Jan-26	Individuals	Estimated Tax Payment	Make a payment of your estimated tax for 2025 if you did not have sufficient withholding.
02-Feb-26	Employers	Form 941	File Form 941 for the fourth quarter of 2025.
02-Feb-26	Employers	Form 940	File Federal Unemployment Tax (FUTA) for 2025.
02-Feb-26	Employers	Form W-2	Give your employees their copies of Form W-2 and file Form W-3 along with Copy A of all the Forms W-2 that you issued for 2025.
02-Feb-26	Employers	Form 1099-NEC	Issue the appropriate Form 1099 to the recipients of certain payments made during 2025.

17-Feb-26	Individuals	Form W-4	File a new Form W-4 if you claimed exemption from income tax withholding in 2025.
28-Feb-26	All Businesses	Forms 1099, 1098, 1096, and W-2G	File Forms 1099, 1098, 1096, and W-2G with the IRS reporting certain payments made during 2024. There are different versions of Form 1099 for different types of payments. Use a separate Form 1096 to summarize each type of payment. For a 30-day extension of time to file, use Form 8809. If electronically filing, the due date is March 31, 2025.
16-Mar-26	Partnerships	Form 1065	File the 2024 tax return (Form 1065) (Including 1065-B) and provide each partner with a copy of the K-1. For an automatic extension, file form 7004.
16-Mar-26	S-Corporations	Form 1120-S	File the 2024 tax return (Form 1120S) and provide each shareholder with a copy of the K-1. For an automatic six-month extension, file Form 7004.

16-Mar-26	Withholding & Reports	Forms 1042, 1042-S, and 1042-T	File Forms 1042, 1042-S, and 1042-T. For an automatic six-month extension of time to file Form 1042, file Form 7004. For an automatic thirty-day extension of time to file Form 1042-S, file Form 8809.
16-Mar-26	Partnerships	Form 8804 and 8805	File calendar year Form 8804 and Forms 8805 to report the total liability under section 1446 for the partnership's tax year or show the amount of effectively connected taxable income (ECTI) and the total tax credit allocable to the foreign partner for the partnership's tax year, respectively. filing Form 7004 is necessary to file for a 6-month extension.
31-Mar-26	All Businesses	Forms 1097, 1098, 1099, 3921, 3922, and W-2G	Due date to electronically file Forms 1099. The deadline for paper filing is February 27, 2026. Due date to electronically file Form 8027.

15-Apr-26	Partnerships	Form 8813	File Form 8813 quarterly payment voucher for first quarter of 2026 and pay any tax due.
15-Apr-26	U.S. Estates and Trusts	Form 1041	File Form 1041 for calendar year entities and pay any tax due. Or file extension granted for 5 1/2 months due September 30, 2026.
15-Apr-26	All U.S. Businesses	Form 1042-S	If extension of 1042-S using Form 8809, Form 1042-S now due.
15-Apr-26	Corporations	Form 1120	File Form 1120 for calendar year and pay any tax due. For automatic 6-month extension, file Form 7004 and deposit estimated tax.
